



POWER INTERRUPTION – MEYERTON AREA

Please accept our apologies for the extended power interruption of 7 February 2010. It was due to unforeseen circumstances beyond the Municipality's control.

Unfortunately due to the extent of the work still to be done at the main substation, we hereby give notice of a further interruption of the electrical power supply affecting the Meyerton area on 14 March 2010 from 05h00 to 22h00. If everything goes according to plan, this will be the last shut down.

This interruption will be due to the upgrading of transformers at the main substation (M1). Eskom is in the process of upgrading the capacity of the substation from 40MVA to 60MVA so as to ensure a reliable supply to the Meyerton area and to accommodate future development.

The electrical supply must be treated as **LIVE** during the off period for safety purposes.

Power failures will not affect the following areas:

KRAGONDERBREKING – MEYERTON AREA

Hiermee bied ons verskoning aan vir die verlengde kragonderbreking van 7 Februarie 2010. Dit was ongelukkig buite die beheer van die Munisipaliteit.

As gevolg van die omvang van die opgraderingsprojek by die hoof substasie en die hoeveelheid werk wat nog voltooi moet word, gee ons u kennis van 'n kragonderbreking op 14 Maart 2010 vanaf 05h00 tot 22h00. Indien alles volgens plan verloop, behoort hierdie die laaste onderbreking te wees.

Die kragonderbreking is nodig vir die opgradering van transformators by die hoof substasie (M1). Eskom is in die proses om die kapasiteit van die substasie van 40MVA na 60MVA op te gradeer om 'n betroubare kragtoevoer na die Meyerton area sowel as genoegsame krag vir toekomstige ontwikkeling te verseker.

Die Elektrisiteitstoevoer moet ten alle tye as **LEWENDIG** beskou word.
