### **NOTICE OF INTENT: SECTION 116 (3) (a) (b) (i) & (ii) PROCESS FOR ENGINEERING SERVICES TO AMEND A CONTRACT FOR THE PROJECT OFFICER APPOINTED FOR THE ELECTRICITY PPP PROCESS FOR THE MIDVAAL LOCAL MUNICIPALITY**

Notice is hereby given in terms of Municipal Finance Management Act (Act 56 of 2003) Section 116 (3) (a) (b) (i) & (ii) read with Section 21 A of the Municipal Systems Act, 2000 (Act No. 32 of 2000) that the municipality has the intention, to amend the contract of the project officer appointed on the Electricity Public-Private Partnership (Bid 8/2/2/177).

### **REASONS FOR THE PROPOSED AMENDMENT WAS TABLED AND APPROVED BY THE COUNCIL AT ITS 4TH MEETING HELD ON 25 APRIL 2018 UNDER ITEM: 9.A.6 - C 1801/04/2018**

Bid 8/2/2/177: Project Officer was awarded to Pro-Active Management Services to the total amount of R1 122 000 VAT Inclusive for a period not exceeding 18 months. The appointment was confirmed by the Bid Adjudication Committee of the Midvaal Local Municipality on 31 March 2016. On 19 May 2016, the award was amended to make provision for a 24-month project period and the amount was amended to R1 475 552 VAT Inclusive.

The process has taken much longer and was much more complex than initially anticipated and as such only phase one of the project was completed in the initial time frames allowed for.

The next steps will be the procurement and contract management phases (Phase 2 of the original bid) and to now have to no longer have the services of the Project Officer will be catastrophic to the project. Taking the above into consideration it is proposed that the contract be extended in terms of Section 116 (3) of the MFMA, for a period of 18 months, not exceeding 31 December 2019 at a cost of R1 337 844.40.

The service provider has indicated their willingness to proceed with the project as per the proposal. The contract amendment as proposed is in line with the pricing of the original bid and it is deemed to be market related. The municipality has the funds available which is co-funded by the National Treasury.

The public is hereby invited to submit written comments or representations within 14 consecutive days from the date of this notice (on or before 17 May 2018), to the office of the Municipal Manager in respect of the proposed amendment. Such comments or representations must be submitted to the under-mentioned address.
