INTERESTED AND AFFECTED PARTIES ARE HEREBY NOTIFIED OF THE REJECTION OF THE REQUEST FOR AN AMENDMENT OF THE VALIDITY PERIOD ON THE WASTE MANAGEMENT LICENCE (WML) FOR THE OPERATION TOWARDS DECOMMISSIONING AND CLOSURE OF HENLEY ON KLIP GENERAL WASTE DISPOSAL SITE LOCATED ON PORTION 1320-1323 OF THE FARM SLANGFONTEIN 374 IR, MIDVAAL LOCAL MUNICIPALITY

The Gauteng Department of Agriculture and Rural Development (GDARD) rejected the amendment application to extend the validity period on the WML for Henley on Klip landfill site sent to GDARD on 20 October 2021. The amendment was rejected by the Department in terms of section 49 (1)(c) [*reject the application where it does not comply with the requirements of this Act*] of the National Environmental Management: Waste Act (Act No.59 of 2008) (As amended). The reason for the rejection of the amendment application was the outstanding Compliance Notice that was issued on 06 February 2020 to the Municipality and was not addressed.

Council thereby notify all I&As of the Departments decision as instructed in terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014 (as amended). Your attention is drawn to Chapter 2 of the National Appeal Regulations, 2014 which regulates the appeal process. Should you wish to appeal any aspect of the decision, you must within **twenty (20) days** of the date of notification of the decision submit your appeal including supporting documents to the appeal administrator by any following means:
